1. Minutes of Meeting held on Tuesday 8th February 2011 at 7.30pm in Village Hall

5. OPEN MEETING
Royal Oak request for additional page in Newsletter. Previous landlords had affixed a sheet.
6. Declarations of interest None
7. Minutes of meeting previously circulated and signed by the Vice Chairman as correct.
8. Matters arising
 - a. HS2 Update, response from NCC Ken Melling stated that he didn't support HS2. It was noted that NCC has made no budgetary provision for HS2. Councillor Russell is liaising with Jo Wilson of Aston le Walls re publicity. Brian Wooding NCC officer had not responded to Clerk's email asking for NCC position on HS2. To be resent. Consultation on proposal due very shortly. Posters cost to be obtained.
 - b. County Councillors Empowerment Fund a) EVH refurbishment heating b) New activity? cinema etc, new club. In general, PC supported the idea of improving small room heating whilst appreciating that only the existing electricity supply can be used for refurbishment. Councillor Blanshard will raise this at Village Hall meeting on Thursday.
 - c. Eydon Burial Ground Fees – Proposed by Councillor Denby and seconded by Councillor Blanshard that the cost of erecting a headstone would be £200.
 - d. Village Green. Land Registry had replied 'Looking at the documents you supplied there is no doubt that the Green has been used for many years by villagers for a wide range of uses both communally and individually. I am sure that is why Northants. County Council accepted the registration as a Village Green under Section 15(1) of the Commons Act 2006. Unfortunately, that registration coupled with the evidence supplied is not sufficient for the Land Registry to grant the Parish Council a registered title to that land.
Although that registration confirms the status of the land as a Village Green it does not confer any legal title to the land on the Parish Council. It may be that you have already done as much as possible in having the land registered as a Village Green as it appears unlikely to me that the evidence you could put forward would be sufficient to establish that the Parish Council had effectively barred the title of the true or documentary title owner. What you have done is establish the fact that the Green has been used in a wide variety of ways but not, in my opinion, demonstrated that the Council has acquired the legal title to that land. This is very difficult to do where the land, by its very nature, is openly accessible and used by many people.' No further action by Parish Council
 - e. Planning- report from Councillor Henson on training session at NCALC stated session helpful but concerned about Section 106 agreements. These

are unlikely in Eydon as developments are likely to be small.

- f. Localism Bill- further information awaited.
- g. Risk assessment checked and all councillors confirmed that the review complied with their wishes.
- h. Internal Audit review was carried out. All councillors were satisfied with the system locally.
- j. Village Design Statement. Next meeting on 1st March 2011. SNC has yet to comment on the submitted document.
- k. Annual Parish Assembly – 19th April 2011 at 7.30pm. Presentations from HS2 and opportunity for Sports Field AGM should earlier date not materialise be made available. Village reports are less necessary with website, welcome pack. Reports from Village Hall, Charities, and ECSF will be given.
- l. Litter pick Saturday 19 March 10am Meet at Royal Oak. Equipment ordered from SNC. Risk assessment as per last year. Newsletter will request residents to contact Councillor Hawes to volunteer. Areas can be litter picked before 19th. All rubbish to be placed outside Burial Ground. Clerk to request SNC to collect once amount known.
- m. ECSF- AGM scheduled for 23rd February at 8pm in Royal Oak. Posters need to be erected by 9th February. Robin Brown, Acting Chairman said that he would leaflet the village. Councillors Broome and Hawes to attend. Should insufficient numbers be present for quorum, then prior to Annual Parish Assembly could be used.
