a) Applications

 i) S/2011/1239/FUL Proposed woodland lodge holiday let to replace existing Semi redundant agricultural building The Stone House Barnets Hill

The Parish Council objects to this application on the following grounds: The proposed dwelling is in open countryside and in the Special Landscape Area (SLA).

It would be contrary to the long-standing policies of S.N.C., which are strongly supported by E.P.C. The most relevant policies being H6 (II) and EV2 concerning dwellings in the open countryside and in the SLA respectively. H6 states that exceptions will only be allowed where "the present and continuing need for a dwelling can be clearly demonstrated to the satisfaction of the local planning authority". There is no "present" or existing exceptional need. In Policy EV 2 none of the exceptions appear to apply to the proposed use.

The Parish Council also has concerns regarding the increased use of the gateway and parking on what is recognised as a dangerous stretch of road. We ask that the application be referred to the SNC Planning committee.
