Preston Road. By prior notification the deplorable state of the road, verges and inconvenience to the residents of this road. Concern was raised at the possible damage to public utilities connections by parked vehicles or delivery vehicles to building sites, from properties with costs being given to householders. Both NCC and SNC are aware. Condition of planning that reinstatement takes place. Work scheduled to be completed by end of March. Clerk to contact Anglian Water re leaking new meter. Clerk to advise County and District Councillors.
