**S/2011/0852/FUL** Burnt Mill Butterfly Lane West Farndon Variation of condition 4 on S/2008/1611/P to allow construction works to the new dwelling to commence prior to NCC Highways commencing associated works. (to slab level)

**DA/2011/0585** Construction of wall and gates to site frontage at Bungalow Farm, West Farndon. It was considered that the proposal, by virtue of its type, scale and design, would create an urbanising feature in an open countryside location. The proposal would be an incongruous feature to the locality where boundary treatments are post and rail fencing or hedges. The proposal site lies in a designated Special Landscape Area and by virtue of the proposal being considered an urbanising feature, which will be seen in prominent public views, the proposal was considered to be detrimental to the character of the Special Landscape Area. The proposal was considered to be contrary to Saved Daventry District Local Plan Policy GN2A, GN2G, EN1D EN42A and EN42C. The applicant has appealed against the decision.
