The Rights of Way officers were present at the request of the Parish Council to clarify why the Butterfly Lane bridleway and specifically the bridge had been closed. Mr. Wicks explained the background to the problem. While the bridge may, as claimed, have been in a similar condition for a number of years once it had been reported and a survey had been conducted confirming that it was not safe, it was a legal requirement to close it for repair or replacement. Hopefully the work would be carried out within the current six month period. Any extension of the period could only be

agreed by reference to the Secretary of State. Mr. Wicks confirmed that despite notices warning the public of the closure there was no reason why the bridleway could not be walked or ridden on providing that the bridge was not crossed.
