

EYDON PARISH COUNCIL

Minutes of the Eydon Parish Council Meeting held from 7.30pm on Tuesday 11th of July 2017 in the Village Hall, High Street, Eydon.

1. **Councillors present:** Cllrs K Simmons (Chairman), C Henson, J Maxted, N Stewart and J Walker. The Clerk was in attendance.
2. ***The Parish Council is to receive and consider for approval apologies for absence.***

Apologies were received and approved from Cllrs R Collins and W Coy.

3. ***Open meeting:*** Members of the public may address the Parish Council at the discretion of the Chairman.

No members of public were present.

4. ***Declaration of Interest on agenda items by Parish Councillors.***

No interests were declared.

5. ***Resolution to approve and sign the Minutes of the Eydon Parish Council Meeting held on the 13th of June 2017 as a true record of that meeting.***

The Parish Council agreed the Minutes to be a true and accurate record and they were signed accordingly by the Chairman.

6. **Matters arising:**

1. In respect of the concerns over speeding traffic along the Byfield/Woodford Rd, correspondence is continuing with the Northants Police and local residents with regard to a speed survey being undertaken prior to further action by the Parish Council.

2. Following the reporting via Street Doctor of an overgrowing field hedge adjacent to the road above Hill View, feedback has been received advising that the hedge was not currently considered to be a road safety issue.

3. With regard to the proposed visit by an Aylesbury Mains representative to discuss the options for replacement street lights, the Chairman advised this was now scheduled towards the end of July.

4. It was noted that the grass verge along the Woodford Rd had again been missed by the mowing contractor, the Clerk shall liaise with the Ground Care Company to address the issue. The Clerk shall also instruct for the pathway from Manitoba Way to Lime Avenue to be mown.

7. Highway and byway issues:

1. *To receive and consider a report from the Highways Warden if available.*

No report was presented.

2. *The Parish Council is to consider correspondence received from NCC Highways regarding concerns over the use of Eydon as a cut-through for large vehicles servicing a business in a neighbouring parish.*

The matter was discussed and the correspondence was noted. On the behalf of the Parish Council, the Clerk is requested to make enquiries with Daventry District Council regarding the consideration of large vehicle movements during the recent planning applications relating to Slade Leys Farm and also the current status of any outstanding applications/appeals.

3. *The Parish Council is to note information received from NCC regarding structural changes and contact details for the Rights of Way team.*
